INTERVAL INTERNATIONAL and DAE UPDATE!



In February, 2016 Christie Village was reinstated into Interval International. This was a major turnaround for our owners because we could once again deposit our units into Interval International Bank and Swap plans. Many of you have already exercised this option.



We also still have the option of using DAE. They have been an excellent partner to deposit our units during the time we

could not use Interval International. Many people still prefer DAE.

Some facts to remember about the two companies:

- There is no fee to belong to DAE
- Interval charges an annual fee
- Both require that your maintenance dues be paid before you Bank and Save a week
- When you Bank and Save a week, this week is good for up to 3 years at both
- Interval has a larger inventory to choose from, when you get ready to book a vacation
- Both charge a fee to book a reservation

Something to remember, you cannot deposit your week if you have not paid your maintenance dues. We had some attempted deposits for 2017 weeks that were not accepted because owners have not paid 2017 maintenance dues. If you want to deposit your 2017 unit, call the Christie Village office to arrange to pay your 2017 dues.

Meet Christie Village Owners - Ann Scott and Wanda Porter

This newsletter we are featuring two owners: **Ann Scott and Wanda Porter.** Why are we featuring two? Because these two ladies have been friends for almost 50 years and they are inseparable.

They live in the Wilmington area.

Ann has been a member at Christie Village since 1981 and encouraged Wanda to join in 2014.

Ann retired from Riegel Paper (which later became Federal Paper and now is International Paper) in 1998 after 38 years of employment. Wanda was the administrative assistant for her husband and dentist, Lee Porter until he passed away 3 years ago.
